- 3. Declaration of Pecuniary Interests there were no declarations of interest
- 4. **Council to agree the minutes of the July 2022 meeting –** Council unanimously approved the minutes of the July 2022 meeting
- 5. & 7 **Public session –** Ffion Horton reported on the plans to signalise the crossing in Cross Houses, indicating that design costs would be £13,000 and installation costs up to £25,000 making around £40,000 in total. Ffion also reported that Shropshire Council would take on the on-going maintenance costs.

It was also noted that public consultation on the extension of the speed limit zones should start as soon as the plans were formally submitted, which it was hoped would by October meeting.

Members of the public expressed views both in favour and against the proposal to install the light-controlled crossing. Concern was also voiced that the proposal was not specifically included in the community-led plan, and therefore should not be paid for by CIL. The Council indicated that it was included in the Parish Council Place Plan, and that road safety and speeding were the highest ranking concern in the community-led plan.
