MINUTES

- 1) Welcome by Chairman: The Chairman welcomed all to the meeting.
- **2) Present and Apologies:** Councillor C Wild- Chairman; Councillor R Purslow-Vice Chairman; Councillor S Mason; Councillor L Picton. Also present L Pardoe, clerk to the council Mr. E Brayne Apologies were received from Councillors M Howorth; S Hawksworth: C Bonsey; R Ward, these were accepted by the Council.
- 3) Declarations of Pecuniary Interest: There were none at this point
- **4) Confirmation and acceptance of the minutes from 7**th **July 2016:** It was agreed that these were a true and accurate record of the meeting; proposed by Councillor L Picton; seconded by Councillor S Mason and agreed by all members present
- 5) Matters arising: There were no matters to report that were not on the agenda.
- **6) Representations from members of the Public:** There were no members of the public to speak
- **7) Police Report-** to be circulated to members when received. Councillor C Wild reported that there had been on road collision recently which resulted in the road being closed for a while.
- 8) Highway Matters: Councillors to report any highways matters

Council to consider sites of Community Concern; It was agreed that the Sites of Community Concern remained the same as the previous year.

- 1. Speeding through the village of Crosshouses remains a grave concern to the residents.
- The Atcham road needs a speed reduction and some passing places
- 3. The disregard of many drivers for the pedestrians using the road crossing is of concern and the members would request that the crossing is upgraded to a Pelican Crossing

The clerk was asked to write to Mrs Parsons at The Hollies and state the Parish Council had passed on their concerns for the state of the road on junction A458 and Noel Hill Road. The road has been marked up and it is expected that some work will begin soon.

Councillor Purslow reported that the hedge at No 5 Russell Place needed cutting back. Clerk to write to letting agent Belvoir's to request they get this done.

The Hedge by the Bus shelter that is owned by Shropshire Homes is getting out of control again. *Clerk to follow this up with Shropshire Homes.*

The clerk had written to Mr & Mrs Talbot requesting they trim their hedge as it was obstructing the roundabout sign. The clerk was asked to request that Colin Blower from Shropshire Council look at this and request they cut it back to stop the obstruction of the signage.

Update from Fletcher Homes: They are awaiting the final ecological checks before the development can proceed. The development is due start this autumn and the vehicle activated signs and other safety signage will be put in place before commencement of construction

11) Correspondence Received: This was noted. It was agreed that Mr Brayne would attend the Battle of Britain service on behalf of the Parish Council.

It was agreed that the clerk would attend the training session on General Power of Competence in September.

It was agreed that the Parish Council would continue on the Joint Energy Scheme with Shropshire Council for the forthcoming year.

12) Parish Matters: Sadly Mr Smith who had been the handyman for the Parish Council for many years had passed away suddenly at the end of July. He had been very involved in the local Onion Society and at their annual event they had raised a sum with which they wished to give to the Parish Council for the purchase of the defibrillator in memory of him.
